


This maintenance record will be a valuable manifest of cumulative information showing the care your Porsche has received in the course of time if you continue to have the recommended inspections completed on schedule and then recorded herein in the same manner as during the warranty period.

A world-wide Porsche service organization is at your disposal.

MAINTENANCE AND LUBRICATION NOTES:

The terms "test" or "check" include all associated work such as adjustments, readjustments, corrections, and replenishing. They do not include the repair, replacement, or overhaul of parts or components.

Please note the information presented in the Driver's Manual.

Present this service record to your Porsche service shop or any authorized Porsche representative inland or abroad when the scheduled inspections or lubrication are being accomplished. This will give you assurance that the necessary work operations prescribed in the maintenance and lubrication schedule will be carried out to our standards.

High caliber work requires cleanliness. It may at times become necessary to wash the car before starting the given service operations.

WARRANTY CLAIMS:

If your Porsche should require any work under the provision of the warranty, please present this maintenance record, which also is a warranty certificate, toyour dealer. The warranty provisions are defined on the next page of this maintenance record.

PLEASE NOTE:

Matters concerning your Porsche can be processed by the Porsche service organization only when the chassis serial number has been included in your correspondence.

THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, MADE BY EITHER THE DEALER, THE DISTRIBUTOR, THE IMPORTER OR DR.-ING. H. C. F. PORSCHE KG. THE MANUFACTURER, OF PORSCHE CARS SOLD IN THE UNITED STATES AND CANADA, EXCEPT THE WARRANTY OF DR.-ING. H. C. F. PORSCHE KG. AGAINST DEFECTS IN MAJERIAL AND WORKMANSHIP SET OUT BELOW:

TERMS OF WARRANTY OF NEW POISCHE CARS SOLD IN THE UNITED STATES OR CANADA

- 1. This warranty applies to new passenger cars of all types and models (except special vehicles as of mpetition versions and racing cars) manufactured by Dr.-Ing. h. c. 5. Porsohe (G of Stuttgart, Federal Republic of Germany ("Porsche"), provided such cars were ordered through an authorized United States or Canadian importer or distributor and sold as new by an authorized Porsche dealer to a retail customer in the United States or Canada, or were ordered and delivered abroad to a bona-fide retail customer who subsequently imported the car into the United States or Canada for his personal use.
- 2. Porsche warrants new cars under normal use and service to be free or defects in material and workmanship for 12 months after the date of delivery of the car to the original retail customer, or until the car has been driven 12 000 miles, whichever event shall occur first. In the event any port of the car becomes defective during the warranty period under normal use and service and the car is brought forthwith to an authorized Porsche dealer within the United States or Canada, the dealer will, without charge, either repair any defective parts or replace them with new or factory reconditioned parts. In all cases, only such parts which, in spite of proper use and service of the Porsche car, became defective due to defective material or workmanship, will be replaced or repaired. All parts which are replaced shall be the sole property of Porsche. Further claims due to direct or consequential damage especially but not limited to telephone fees, lodging expense, loss or damage of personal or other property, loss of revenue or expense for towing, are excluded from this warranty.

THIS WARRANTY IS SUBJECT TO THE FOLLOWING ADDITIONAL CONDITIONS, LIMITATIONS AND EXCEPTIONS:

- Warranty claims can be made only through an authorized Porsche dealer and must be made forthwith upon ascertainment of a defect claimed under this warranty. All work and services to be performed in connection with this warranty claim must be performed by an authorized Porsche dealer.
- 2. This warranty shall be deemed to be fully discharged:
 - a) if the car has not been maintained and serviced as prescribed in the Porsche Maintenance Record, Porsche Driver's Manual or other similar publications pertaining to the operation or maintenance of Porsche Products prepared or approved by Porsche; or
 - b) if parts, other than genuine Porsche parts, have been installed, the use of which has not been approved by Porsche, and in the sole judgement of Porsche the defect or damage is casually related to the installation of such unapproved parts; or
 - c) if damage was caused by misuse, negligence or accident of any kind for example by overstraining, when training for, or participating in rallyes, races, or any form of competition.

- 3. This warranty also does NOT cover:
 - a) normal wear and tear and normal maintenance services, including but not limited to periodic inspections, engine tune-ups, wheel alignment and wheel balancing, carburetor, brake and clutch adjustments, fuel injection and fuel pump adjustments;
 - b) parts which have to be replaced in the course of normal maintenance and service, including bet not limited a air, oil and fuel filters;
 - c) wear parts such as light bulbs, fuses, spark plugs, ignition or distributor points, condensers, wiper blades, clutch and brake linings;
 - d) defects, damage, deteriosation or wear caused by normal use, exposure
 to the elements or other external influences, or the misuse of cleansers,
 polishes or waxes to such parts or items (but not limited to such parts
 or items) as paints, rubber, upholstery, chromed and wooden parts;
 - glass breakage or scratches in the absence of positive evidence of manufacturing responsibility.
- Where warranty claims are allowed based on defective paint, repainting will be limited to repainting the body part involved.
- This warranty also does NOT apply to tires, tubes or radios, as such items are covered by a warranty of their respective manufacturers. (The customer should contact any authorized Porsche dealer with respect to questions in connection with such items.)
- There shall be no right of rescission or to any reduction in the purchase price or to the delivery of another Porsche car unless Porsche is not able to cure the defect coming within the provisions of this warranty.
- 7. This warranty does NOT apply in the event a Porsche car is brought to an authorized Porsche dealer outside the United States or Canada, in which event the terms, conditions, limitations and exceptions of the warranty for Porsche cars in effect in such other country or area shall apply.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER EXPRESS OR IMPLIED WARRANTIES, OBLIGATIONS, OR LIABILITIES OF PORSCHE, THE IMPORTER, THE DISTRIBUTOR AND THE SELLING AND/OR DELIVERING DEALER, WHETHER FOR DIRECT OR CONSEQUENTIAL DAMAGE OR OTHERWISE, INCLUDING OBLIGATIONS FOR BREACH OF EXPRESS OR IMPLIED CONDITIONS AND INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND PORSCHE, THE IMPORTER, DISTRIBUTOR AND THE SELLING DEALER NEITHER ASSUME NOR AUTHORIZE ANY OTHER PERSON TO ASSUME FOR ANY OF THEM ANY OTHER LIABILITY IN CONNECTION WITH SUCH MOTOR VEHICLE OR SPARE PARTS!




